# NOTICE FOR CANADIAN CLIENTS

Reliance on International Dealer Exemption ("the Exemption") pursuant to subsection 8.18(2) of National Instrument 31-103 *Registration Requirements, Exemptions and Ongoing Registrant Obligations* ("NI 31-103") and Notification to Permitted Clients of the prescribed information under subsection 8.18(4)(b) of NI 31-103

Please note that as you are a client domiciled in Canada, when Vontobel Securities Ltd ("VonSec") trades with you it does so in reliance upon the Exemption (as such Exemption may be amended and restated from time to time) from the dealer registration requirement under NI 31-103. Pursuant to the Exemption, VonSec is currently subject to certain restrictions, including, among other things, that VonSec is only permitted to trade "foreign securities" with "permitted clients" resident in certain provinces or territories of Canada. A foreign security is a security issued by an issuer incorporated, formed or created under the laws of a foreign (i.e., non Canadian) jurisdiction or a security issued by a government of a foreign jurisdiction. This serves to put you on notice that you should only place orders with VonSec for foreign securities in accordance with the Exemption. VonSec may ask for additional documentation or confirmations from you in order to ensure that its activities are in accordance with the Exemption, including documentation to confirm your status as a permitted client.

### Please also note that:

1) VonSec is not registered in Canada and is dealing with you, its client, in reliance upon an exemption from the dealer registration requirement under NI 31-103.

2) The jurisdiction of VonSec's head office or principal place of business is in Zurich, Switzerland:

4) There may be difficulty enforcing legal rights against VonSec because it is resident outside of Canada and all or substantially all of its assets may be situated outside of Canada.
